Supporting Provider Reporting

What is Cocoa?

- The **web-based data system** to track family demographics and child enrollment, attendance, screenings and assessments for Early Learning Scholarships.
- Cocoa data is used to calculate monthly payments for certain ELS providers and to understand the development/outcomes of young children in San Francisco.

Who is Required to Use Cocoa?

- **ELS-Reserved**, **ELS-Reserved (Moderate)** and **ELS-Gap** providers must enter and update information in Cocoa for all enrolled children.
- **Preschool for All (PFA)**-only providers must enter and update information in Cocoa for PFA children. Entering non-PFA children is optional for these providers.

What's New in Cocoa?

Certification Deadline

- Sites must now certify their data by the third business day of each month. The **first monthly certification deadline is August 3** (based on your July data).
- Who can submit and view certifications has not changed. Each agency submits a single certification for the entire agency. Only Agency Admin. accounts can submit certification on behalf of whole agency; Site Admin. accounts can only view certification.

ELS Funding Types and Fields

- Sites must assign a **funding type to each enrolled child**. For a list of current funding types, see "New ELS Funding Types" handout.
- There are **new required fields** for ELS reporting, including families' homeless status and special need of the child. See "Cocoa Reporting Requirements" handout for specific required fields.

Attendance Tracking

- Sites must track **daily attendance in Cocoa** either through the simplified manual Enter Attendance feature or through E-Signature.
- For those ready to adopt the E-Signature feature, please attend the **E-Signature Overview Training** on Wednesday, August 16 from 1-3 pm or Tuesday, August 22 from 6-8 pm. RSVP to Emily Kraybill at 415-343-3358.
- For children receiving ELS-Gap on APP/CalWORKs Voucher, sites will continue to submit monthly Children's Council/Wu Yee timesheets.

Data Acknowledgement Form

- Prior to entering family/child data in Cocoa, **families must sign a form** acknowledging that their child's information will be shared with OECE.
